 - Prof Anil Bhardwaj (Director, PRL Ahmadabad); Prof Tom Wada (Dean, Kyukus Univ Japan); Ms Dibya Saxema (French Embassy France); Mr Akshat Agrawal (Consultant STartup, IIT Delhi); Ms Chestha Sharma (Director, IIPT); Prof A Subbarao (Preseident, Indian Innovation Associate); Mr Reapon Tikoo (CEO Pawai Lab); Mr Prashant Admane, Group Tech Manageger HCL Technogies); Mr Rajendra Inani, Business Head, Smart Cities TATA projects); Dr Nitin Kale (Cofounder & CTO, NanoSniff Tech Pvt Ltd, IIT Mumbai) and many more.
 - Dr. Anil Gupta, IIM Ahmedabad; Mr. Greet, Belgium, and Mr. Ajay Garg, Meity, New Delhi were available for the online session. Idea Competition was also organized.

Item 28.10	Suggestions to handle the habit of late semester registration by students

The following rules for semester registration were approved by the Senate to curb the menace of late registration by the students.

Let the date of registration is day 0. Then, registration on ...

- Day 0: Actual semester fee as per the program and category
- Day 1-4: Actual semester fee as per the program and category + late fee (Rs.2,000/-)
- Day 5-25: Actual semester fee as per the program and category + Late fee (Rs.2,000/-) + Rs.500/per day starting day 5.
- Registration after Day 25 may be allowed only with a condition of semester withdrawal. However, the late fee is not applicable in this case.

Item 28.11	Finalization of SPGC and SUGC preliminary reports on new curriculum design
------------	--

The Senate suggested following to complete the design of new curriculums for various programs in order to implement them from July 2023.

- The SPGC, SUGC, and HoDs are required to convene their meetings frequently to finalize the courses.
- 2. The first year of B. Tech., BS, IMT, and IMG across all the five department should be exactly same as the students may change branches after first year.
- 3. The programs should be designed keeping in mind the exit option after every year in the program.
- 4. A core course in one program may be an elective course in another program.
- 5. Each UG/IPG program should create a basket of courses that would define a minor degree in that program in another (major) program.
- There should a be synchronization of courses of UG/PG at semester level in the programs across
 all the departments to reduce teaching loads in the departments and enable them to offer more
 electives.
- Massive Open Online Courses (MOOCs) should be introduced in the programs as per the guidelines
 of the New Education Policy (NEP) 2020.
- 8. Some optional courses in each semester and summer should also be offered to enable students to complete the course in effective way.
- 9. Last semester of UG/PG courses should be electives/MOOCs to enable students to opt for the internship/research/projects in industry/ institutions.
- 10. The template of the courses will be provided by the DoAA to HoDs to complete the contents, objectives, references, etc.

As the institute wishes to have zero tolerance in the unfair means, the Senate approved the following changes in the existing UFM rules 2022 that were approved by the senate in its 26th Meeting.

He has been allowed to start from the third semester since 2022-23 with the batch of 2021 on his request. However, he has paid the fee for 2020-21 and 2021-22 to retain his studentship.
 - ii. Majirana Rahulkumar Lekhrajji (2021IMT-061) took admission in the year 2021-22 but did not show up. He has been allowed to start from the first semester since 2022-23 with the batch of 2022 on his request. However, he has paid all the fee to retain his studentship.
 - iii. Raval Maheshbhai Jivabhai (2021IMT-079) took admission in the year 2021-22 but did not show up. He has been allowed to start from the first semester since 2022-23 with the batch of 2022 on his request. However, his full fee of second semester and hostel and mess fee of third semester is still due.

Senate approved the termination of Bhupendra Meena (2014IPG-030) who was allowed to clear his backlogs by the semester Jul – Dec 2022 as per item 24.16 in the 24th Senate meeting held on 23 May 2022 with a condition that no further extension would be provided. - The Chairman, Senate suggested to confer Honorary Degree (DSc Honoris Causa) to the eminent personalities in various walks of life, e.g., education, research, business, sports, culture, social service, in the convocations. The research proposals under the Research Initiation Grant (RIG), already approved by the FC/BoG in its meeting held in Nov 2008, should be called for from the new entrants, i.e., faculty members. It should be for the Assistant Professor level who has joined this institute first time. They should apply as per guideline approved by BoG within a year of their joining.

4. As Dr. Rajeev Jyoti never attended any of the previous four Senate meetings and he did not respond also. It was decided that some other eminent personality should take his place in the Senate. Senate chairman is authorized to nominate such persons after getting the feedback from the senators.

Comprehensive examination of research scholars pursuing PhD

Eligibility criteria for Comprehensive Examination

Students who have completed the stipulated quantum of course work with specified Cumulative Grade Point Average (CGPA) requirements. In addition, the student should not be under any disciplinary action.

Timelines for the Comprehensive Examination

The student is expected to complete his/her comprehensive examination as per the following timeline.

- PhD students admitted directly with a B. Tech. degree: Within five semesters (05) after admission in the PhD program.
- PhD students after completing M. Tech. / MBA / M.Sc.: Within three (03) semesters after admission in the PhD program.
- PhD students migrating from M. Tech.: Within three (03) semesters from the date of joining the PhD program.

The comprehensive examination will be conducted by the student research committee (SRC) of the student and for this purpose SRC may be termed as comprehensive examination board.

Process of Comprehensive Examination

The assessment process of a student in the comprehensive examination will consist of 100 marks and may involve the following components.

- 1. Performance in course work. (30% component)
- 2. Written test to assess proficiency in fundamental and advanced concepts in the chosen area of work as well as broad area of their discipline.
- 3. Oral discussion-based examination after a student's presentation to demonstrate preliminary understating of literature and methodological approaches/existing tools and techniques in the chosen area of work.

Operationalization of these components will be as follows.

Ouestion paper for the written examination

Head of respective departments will set the question paper for written test of comprehensive examination. If the head of department has conflict of interest, then he/she may assign and get question paper from a senior teacher in the department. Mery

Duration of written examination

The written component of comprehensive examination may be of one/two hours duration. Appropriate duration of examination may be decided by the SRC of the student. Test questions may be of multiple-choice type, essay-type and problems/computational type.

Description of evaluation components

A student's CGPA in the course work may be directly converted into percentage by multiplying 10. Thirty percent of the score so derived will constitute 30% of the component of the comprehensive examination.

Students will be assessed for their understanding of fundamental and advanced concepts in the broad area of their discipline that will be relevant for their future research.

Students will be assessed for their understanding of research problem formulation, experiment design and knowledge about various methodological approaches. Students are also expected to have some preliminary understanding of literature in their discipline.

Outcome: Student will pass the comprehensive examination if he/she obtains at least 60% percent marks in the comprehensive examination. Students will be provided with two (02) attempts to clear the comprehensive examination. A student will be provided with a second attempt if he/she could not clear the examination in the first attempt. A student may appear for second attempt anytime within three (03) months of time from the date of first attempt examination.

SRC of the student will notify the result of the comprehensive examination in the specified format to the Dean of Academic Affairs.

After clearing the comprehensive examination, a student will be eligible for "State-of-the-art Seminar". A student needs to present and clear the state-of-the-art Seminar within six months from the date when he/she has cleared the comprehensive examination. The outcome of the state-of-the-art Seminar may be satisfactory or unsatisfactory. SRC of the student will notify satisfactory performance in the State-of-the-Art Seminar in the specified format to the Dean of Academic Affairs. In the case of unsatisfactory performance, the student will be asked to improvise and appear for the state-of-the-art Seminar again withing three months (03) of time from the date of the first seminar.

"Disciplinary action may involve debarring a student from academic activities for a specified period. Disciplinary action in initiated if a student is involved in ragging, sexual harassment, and any other violation of law. Students are also expected to respect and maintain social decorum and good citizenship behavior. Disciplinary issues pertaining to a student may span evading any rules and include issues such as cheating in examination, copy and pasting in assignments, submitting assignment that is not a student's original work, plagiarism, harassment of fellow students, staff, or faculty members, etc. These violations will be addressed as per existing regulations of the Institute.
