Minutes of the 50th (04/2024) meeting of Building and Works Committee held by circulation (sent on July 01, 2024)

The 50th (04/2024) Building and Works Committee meeting was held by circulation by sending agenda on July 01, 2024 giving time for reply latest by July 05, 2024.

The item wise minutes of the meeting are as follows:

Item 50.1	Construction of Covered Path between LRC and Lecture Hall Complex-1 at Institute Premises.

The BoG in its 58th (02/2024) meeting held on 3rd June 2024 has approved the minutes of 48th B&WC meeting (recommending construction of covered connecting path between Learning Resource Centre (LRC) and Lecture Hall Complex-I) based on the recommendations and approval of the 49th Finance Committee meeting at an estimated cost of Rs. 70,27,600.00 [Rs. Seventy Lacs Twenty Seven Thousand Six Hundred Only]. Accordingly, a letter No.- ABVIITMG/Reg./2024/3859 dated 24 June 2024 was sent to CPWD fortaking up the construction activities as per the specifications and estimate submitted by CPWD in the premises of ABV IITM Gwalior.

In response to our letter dated 24 June 2024, CPWD vide their letter dated No 23(806) GDC/2023/1186 dated 26.06.2024 have informed that a work of construction of 500 Bedded boy's hostel is already going on in Institute premises whose estimated cost is 36.69% less than tendered cost, so CPWD may be allowed to allot this work also to the same contractor so as to get the economical construction and saving Govt. money.

The B&WC considered the proposal of CPWD and approved the same for award of contract to CPWD as proposed by them.

Item 50.2	Construction of Foundation for the Statue of Late Shri Atal Behari Vajpayee and erecting the metal Statue on the foundation made by CPWD

The BoG in its 58th (02/2024) Meeting held on 3rd June 2024 has approved the minutes of 49th B&WC meeting (recommending Modified estimate for the foundation of the Statue of Late Shri Atal Bihari Vajpayee Ji) based on the recommendations and approval of the 49th Finance Committee meeting at an estimated cost of Rs. 49,40,000.00 [Rs. Forty-Nine Lacs Forty Thousand Only].

Accordingly, a letter No.-ABVIITMG/Reg./2024/3858 dated 24 June 2024 was sent to CPWD for taking up the construction of the foundation for installation of the above statue as per the specifications and estimate submitted by them and arrange to procure and install the metal statue of Bharat Ratan Late Shri Atal Bihari Vajpayee Ji on the structure so constructed for this purpose as per the approved design and specification

In response to our letter dated 24 June 2024, CPWD vide their letter No. 23(806) GDC/ 2023/1169 dated 26.06.2024 have informed that a work of construction of 500 Bedded boy's hostel is already going on in Institute premises whose estimated cost is 36.69% less than tendered cost, so CPWD may be allowed to allot this work also to the same contractor to get the economical construction and saving Govt. money.

In addition to above, the BoG has also approved an estimate of Rs. 15,00,000.00 towards the cost of 9 feet high metal statue of Bharat Ratan Late Shri Atal Bihari Vajpayee Ji to be erected on the foundation constructed by CPWD as per actuals.

B&WC considered the proposal and approved as per the agenda item as proposed.
