**Admissions Notice for Two Years Full-Time Master of Business Administration (MBA)
Programme (Academic Session 2026-2027)**

ABV-IIITM Gwalior, Madhya Pradesh is an autonomous institute established by Ministry of Education, Govt. of India in 1997 with a vision of creating professionals in areas of management and technology. The Department of Management Studies (DoMS), ABV-IIITM Gwalior, aims to develop holistic and responsible leaders by creating insightful knowledge and transforming human endeavors through technology-enabled management solutions.

The DoMS is seeking the applications from bright aspirants for its Two Years Flagship Master of Business Administration (MBA) programme with below mentioned eligibility criteria. The programme covers management domains like Marketing, Finance, Operations, IT & Systems and Human Resource Management. It offers a diversified pool of electives in the said areas alongside the research-based internship.

Eligibility: The candidates having the following qualifications are eligible to apply for admission to the Master of Business Administration (MBA) Programme at the ABV-IIITM Gwalior.

- (i) A First-Class Bachelor's Degree with minimum of 60% marks or 6.50 CGPA on a 10-point scale or equivalent in aggregate (of all the years/semesters) in any discipline awarded by any of the universities incorporated by an act of the central or state legislature in India or other educational institutions established by an act of Parliament or declared deemed-to-be-University under Section 3 of the UGC Act, 1956, or equivalent qualification recognized by the Ministry of Education, Government of India.
- (ii) The Bachelor's degree obtained by the candidate must have (a) Mathematics/Statistics as one of the courses, and (b) a minimum of three years of education after completing higher secondary schooling (10+2) or equivalent.
- (iii) A Valid CAT/MAT/CMAT/ATMA/GMAT/GRE/CUET Score.

Note:

- (a) Candidates appearing for the final year of bachelor's degree and those who have completed degree requirements and are awaiting results can also apply. However, such candidates, if selected, are required to submit the degree certificate before registration for the programme. Failing which their admission shall stand cancelled.
- (b) A relaxation of marks or equivalent in CGPA for the SC/ST/PwD candidates as per GoI Norms.

The application fees for General and OBC candidates is Rs 1000/- and Rs. 500/- for SC/ST/PH/Female candidates.

The applicants fulfilling the above mentioned eligibility criteria are required to submit the completely filled-in online application form available at institute website along with applicable fee details and relevant enclosures latest by 3rd March, 2026.

Selection Process:

- 1) In general, the selection process for eligible candidates will comprise of Written Test, Group Discussion (GD), Writing comprehension, Extempore and Personal Interview (PI).
- 2) **The admission process to be carried out at five centers namely Gwalior, Delhi, Bangalore, Calcutta and Guwahati to reach at various locations all over India for better response from the aspirants.**

Non-refundable Admission fee:

Provisionally selected candidates for admission to MBA programme are required to deposit the Non-refundable Admission fee amounting **Rs. 40,000/-** latest by **07th April, 2026**. This Non-refundable Admission fee is considered to be a part of MBA programme fee.
